Brad Kemp is director of regional research at Beacon Economics. A well-known expert on California labor markets, Mr. Kemp was a labor research analyst for the California Employment Development Department (EDD) for over 7 years. During this time, he amassed singular expertise in the collection, reliability, and applicability of labor market statistics in the state. Focusing on the greater Los Angeles region, Mr. Kemp was instrumental in helping leaders, workforce/economic development officials, and city planners use statistics to make better-informed choices and develop effective labor market strategies. He was responsible for releasing the monthly employment estimates and unemployment rate for Los Angeles County, and worked on special reports that detailed the effects of major events, such as the Southern California wildfires, on regional labor markets. Mr. Kemp played a key role in communicating EDD's data and message to a variety of audiences, becoming both a widely quoted source in the media, and regularly presenting at conferences, business gatherings, and regional events.
